#### SPECIAL OPERATIONS ASSOCIATION

The SOA, established in December 1977, is a fraternal veteran's organization of past and present American and Allied military personnel who have conducted special operations in a combat environment. The group includes veterans from World War II, Korea, Vietnam, Panama, Grenada, the Balkans, Somalia as well as those from our most recent conflicts in Afghanistan and Iraq. Membership is limited to Free World forces who supported, or personally participated in missions deep inside hostile territory in a combat capacity.

For the most part, the SOA is composed of U.S. Army Special Forces personnel but, also includes USAF Air Commandos/FAC's, Navy Seals, Marine Raider, and Force Recon personnel and veterans of other elite military organizations who were an integral part of Special Operations.

The specific and primary purposes of the SOA are:

To unite fraternally all veterans who have or are now conducting or supporting classified "Special Operations" deep in hostile enemy territory or have been assigned to military units which conducted such operations; and,

To perpetuate the Special Operations "esprit de corps"; and,

To commemorate fittingly the memory of those who have given their lives in defense of the Free World and to those who served in Special Operations units and are still unaccounted for as POW/MIA through the management of the SOA George C. Morton Memorial Scholarship Grant Fund. Since 1983, over \$556,500 has been awarded, or committed thus far to 152 deserving young scholars.

The Special Operations Association is recognized by the Department of Defense and by the IRS as a non-profit veterans organization, 501 (c) (19), operating on tax deductible donations, (EIN # 74-2619854). Annual membership dues are \$30 U.S. Lifetime membership fee is \$505 U.S. 70-years or over, Lifetime fees are \$305. U.S. The organization has no meetings other than its annual reunion. The primary organizational correspondence is the Pre-Reunion Packet (PRP) and the Special Operations Association Reunion After-Action Report, (SOAR AAR).

The SOA will conduct its 38th annual reunion (SOAR XXXVIII) in Las Vegas, Nevada at the Orleans Hotel and Casino during the period 20-24 October 2014. We anticipate in excess of 650 members and guests.







#### SECRET GREEN BERET COMMANDOS IN CAMBODIA

A Memorial History of MACV-SOG Command and Control Detachment South (CCS), And Its Air Partners, Republic of Vietnam, 1967-1972

#### About the Book

We could call this book "special operations Recon Mission Impossible." A small group of highly trained, resourceful US Special Forces (SF) men is asked to go in teams behind the enemy lines to gather intelligence on the North Vietnamese Army units that had infiltrated through Laos and Cambodia down the Ho Chi Minh trails to their secret bases inside the Cambodian border west of South Vietnam. The covert reconnaissance teams, of only two or three SF men with four or five experienced indigenous mercenaries each, were tasked to go into enemy target areas by foot or helicopter insertion. They could be 15 kilometers beyond any other friendly forces, with no artillery support. In sterile uniforms - with no insignia or identification, if they were killed or captured, their government would deny their military connection. The enemy had placed a price on their heads and had spies in their Top Secret headquarters known as SOG.

SOG had three identical recon ground units along the border areas. This book tells the history of Command and Control Detachment South (CCS). The CCS volunteer warriors and its Air Partners- the Army and Air Force helicopter transport and gunship crews who lived and fought together and sometimes died together. This is the first published history of CCS as compiled by its last living commander some forty years after they were

disbanded. It tells of the struggles and intrigue involved in SOG's development as the modern-day legacy of our modern Special Operations Commands. Forbidden to tell of their experiences for over twenty years; their After Action Reports destroyed even before they were declassified surviving veterans team together to tell how Recon men wounded averaged 100 percent; and SOG became the most highly decorated unit in Vietnam and all were awarded the Presidential Unit Citation.

#### About the Author

Lieutenant Colonel Lindsey enlisted in the Army in 1948, attaining the rank of Corporal. He was accepted in to and graduated from the US Military Academy at West Point in 1954 as a 2nd LT of Infantry. After Infantry School, he qualified as a Master Parachutist and as a Ranger. He served in various leadership and staff positions in the 11th Abn Div, the 82nd Abn Div and the 101st Abn Div. In his first Vietnam combat tour he was MACV G-3 Air Liaison Officer for the 35th Tactical Fighter Wing and flew 50 backseat missions, primarily in F-l00s. Then he went to 1st Brigade of 101st Abn Div as Asst Ops Officer and then Ops and Exec Officer of the 2/327Abn Inf Bn. On his second Vietnam tour, he was Cmdr of 2/8th Cav Bn of 1st Cav Div. Next he was Deputy Cmdr of OP-35 in MACV-SOG and then was Cmdr of Command and Control Detachment South (CCS) from January-July 1970. He is the last living Cmdr of CCS. His advance schooling included the USMA Preparatory School, a Masters degree at Indiana University, and the Command and General Staff College. He retired after 20 years from the Army in August 1972. His civilian career positions included Exec VP of an architectural and engineering firm; and president of an "Alternative Energy" firm building a Gasohol plant. He served for 12 years in the Indiana Department of Commerce as Program Manager for High Technology Development. His military awards include two Legion of Merit, two Bronze Stars, six Air Medals and the Combat Infantry Badge. Civilian awards are as a Kentucky Colonel and a Sagamore of the Wabash. He is active in local service and veterans' organizations in Carmel, IN, where he has lived with his family since 1973.



It has to be an omen that the unit I flew with was the only A-1 unit whose very existence was totally based on the dictates of MACVSOG influences at the JCS or above. These joint conversations should continue and be expanded to welcome all USAF pilots who flew in direct support of SOG teams. I suspect that will happen over time.

The meeting this year was very emotional for all concerned...we laughed and we cried. I suspected that some attending would be surprised to see "fly boys" displaying such a range of emotions. The fact that OLAA flew nearly half of all its missions supporting SOG teams left no room for detachment prior to or after missions. We knew that our efforts could often turn the tide and we had a feel for the risks the teams accepted on a daily basis.

The comments I have received from the OLAA pilots and others in attendance bear witness that something special happened at the Symposium this year.












## Alex Quade Presents "Horse Soldiers of 9/11"



Freelance war reporter, Alex Quade, appeared at SOAR XXXVIII where she presented her recently produced and directed short documentary about the Green Berets in Afghanistan, "Horse Soldiers of 9/11." It is narrated by actor Gary Sinise.

She also presented a video on her history as an award-winning war correspondent who has covered U.S. Special Operations Forces on combat missions for more than a decade. She is the recipient of two national RTDNA Edward R. Murrow Awards as well as the Congressional Medal Of Honor Society's "Tex McCrary Award For Excellence In Journalism" for her war reportage. The Medal of Honor recipients present the award to individuals who, through their life's work, have distinguished themselves by service or unbiased coverage of the United States Military through journalism. Prior recipients of this prestigious award include broadcasters Mike Wallace, Tim Russert, Paul Harvey, and author Joe Galloway.

The Congressional Medal of Honor Society recognized Ms.Quade, "for her courageous reporting and honest news coverage."

Ms. Quade has worked in television for Fox News and CNN where she has embedded with elite combat units several months at a time, producing exclusive, long-form, special series and documentaries.

Alex Quade serves on the Board of Military Reporters and Editors, the Association of Military Journalists, and has been embedded with every branch of the U.S. military.

## Col. Sully H. De Fontaine, USA (R) Distinguished Service Award



COLONEL SULLY H. DE FONTAINE

Inducted 20 August 2009



Born in Brussels, Belgium to French parents, Colonel Sully H. de Fontaine began his Special Operations career during World War II, when, in 1943 he became a member of the Office of Strategic Services (OSS). Trained by the Special Operations Executive (SOE) and the Special Air Service in England, in 1944 he parachuted into occupied France where he escorted downed pilots to safety. After the liberation of France he was attached to the OSS-SOE Operations in Brussels, Belgium and following the war, he attended French, Belgium, and British Military Schools, as well as earning a Bachelors of Arts degree in Philosophy.

In 1956 he was sent TDY to the 10th Special Forces Group (Airborne) during the Hungarian uprising. Colonel de Fontaine completed the Special Forces Qualification Course in April 1957, and after served as an instructor at the Special Warfare School at Fort Bragg, North Carolina, teaching Soviet Intelligence, Escape and Evasion, and Counter Guerilla Warfare from 1957 to 1959. Following this assignment, then First Lieutenant de Fontaine returned to the 10th Special Forces Group (Airborne) in Bad Tolz and became the security officer for the Group. During this time he was in charge of the Congo Operations, which evacuated over 200 stranded missionaries from the remote jungle areas. In 1962 he deployed to Algeria, serving as an observer with French Paratroopers during the Algerian War. In 1963 he joined the 5th Special Forces Group (Airborne) and took an "A" Team to Vietnam. In 1965 Colonel de Fontaine commanded a "B" Team in the Vietnam Delta. He was then assigned to the Studies and Observation Group (SOG) where he recruited and trained Montagnard tribesman for cross boarder operations.

In 1966 Colonel de Fontaine became a Military Police Officer and was assigned as the commander of a CID Detachment in France. In 1968 he was redeployed to the Republic of Vietnam as the Officer in Charge of the Special Branch of the Criminal Investigation Division and afterwards transferred to the Criminal Investigation Agency in Washington D.C. From 1971 to 1973 he was the Provost Marshall of the 1st Armored Division in Bavaria, Germany. In 1973 he was called to be the Field Element Commander of the Joint Casualty Recovery Center, a Special Operations effort in Southeast Asia, and directed operations that recovered remains of personnel listed as missing in action.

Upon Colonel de Fontaine's retirement in 1976 he continued utilizing the professional skills developed as a Special Forces and Military Police officer. His civilian occupations included Special Agent - Western Montana Bureau of Investigations; Senior Agent-Nevada Gaming Control Board; Senior Vice President, Corporate Security, United Gaming Inc. Las Vegas, Nevada; President, International Consulting Agency, Inc.; Corporate Investigator, Park Place Entertainment, Inc., Las Vegas, Nevada; and Director of Investigations, Venetian Macau LTD., China.

During his service he was awarded over 20 US and Foreign decorations and awards to include the Legion of Merit (1 Oak Leaf Cluster), Bronze Star Medal with "V" device, Purple Heart (1 Oak Leaf Cluster), Meritorious Service Medal, Joint Service Commendation Medal with "V" device, Army Commendation Medal with "V" device, Air Medal with "V" Device, Armed Forces Expeditionary Medal, Combat Infantryman's Badge, Master Parachutist Badge, and British Special Air Service Parachutist Badge.

Colonel de Fontaine and his wife Angelique have one son, Christian, who resides in Seattle, Washington with his wife Reneta and son, Andre.

The election final results are:

I received 147 envelopes that contained SOA ballots. Each of those submissions I personally checked with SOA Membership Committee Chairman Ray Calafell for the eligibility status of each member

Rick Estes received 132 votes for PRESIDENT. Five ballots had no check mark for this post.

Tyler Furbish received 100 votes for VICE PRESIDENT. Candidate John Russell received 38 votes for vice president. One ballot had no VP vote.

Tom Cunningham received 90 votes for DIRECTOR. Candidate Jim Day received 47 votes for director. One ballot was disallowed in the director column because the member voted for both candidates.

Write-ins:

### **Ballot Oddities:**

Five ballots were NOT tallied because they had no name and no SOA #.

Two ballots were eliminated for technical irregularities: One member hadn't paid his dues, a vote was cast after a member had died.

The ballot of one associate member was not tallied. Associates can't vote.

The votes on incomplete ballots were counted. All votes were tallied.

### Final Disposition:

All ballots have been retained and will be hand delivered to SOA Secretary David Lucier at SOAR XXXVIII, to be destroyed 30 days after today's tally, unless the SOA President asks for a delay for the good of the SOA.


### Final Tally:

## SPECIAL OPERATIONS ASSOCIATION SCHOLARSHIP PROGRAM

FACTS: The Special Operations Association Scholarship Grants are awarded by the SOA and must be used at an accredited, Junior College, Community College, Four-year College or University for studies which will lead to a Bachelor's Degree. Each Grant is for \$1,000 per semester not to exceed \$2,000 per year (Maximum of four (4) years and paid at the rate of \$1,000 per Fall and Spring Semesters).

BASIC GRANT CRITERIA AND ELIGIBILITY: A high school graduate or a high school student anticipating graduation during the year of application, unmarried or married and under the age of 21 years at the time of application and must be a son, daughter or grandchild, natural or legally adopted, of an individual who served in a Special Operations unit and is a SOA member in good standing and such SOA member remains a member in good standing for the duration of the scholarship awarded. An applicant who is the child or grandchild of a MIA or KIA who was a member of SOA or who would have been eligible to be a member of SOA is also eligible to apply. A student who is already attending an institution of higher learning may apply, provided that they were under 21 years of age at the time that they began their studies at the institution, and have been enrolled full-time and in good standing since beginning their studies.

APPLICATIONS: Application packages are available from 15 September of the previous year to 15 March of the year that the grant will be awarded. The deadline for the submission of all formal applications is 15 April of the year the grant will be awarded.

AWARDS: On approximately 1 July of that year, selectees/recipients of a Special Operations Association Scholarship Grant will be appropriately notified by mail.

INFORMATIONAL: As of September 2014, 152 young men and women have been awarded a scholarship since the program began in 1983.

## George C. Morton Memorial Scholarship Program Annual Report 2014

### **Recipient Status**

- Two Class of 2015 students, Sloan Elizabeth Shank and Bailey Alexandra Oas remain in the program.
- Three Class of 2016 students, Andrea Deuschle, Danielle Susan Edwards, and Samantha Shipman, remain in the program. One Class of 2016 student, Ms. Lynsey Anttila, is on hold with the program, pending her completion of short-term military training service. She intends to return to college full-time after her active duty military service obligation, and if she does so, she will be reinstated in the program.
- Three Class of 2017 students, Sloane Echevarria, Elizabeth Oden, and Shannon Randall, in addition to Ms. Shipman, Class of 2016 noted above, remain in the program.
  - One Class of 2018 student, Mr. Sean L. Wilson, is a new recipient this year.
- Nine scholarship recipients therefore are currently active and ten remain eligible in the program this semester. The following is an overview of recipients by class, not including the student who is on hold:

    Juniors 3
    Sophomores 3
    Freshmen 1

The eligible nine scholarship active recipients have been or will be sent checks for the 2014 Fall Semester.

### **Summary:**

Current scholarship value for four years is \$8,000. Stipend checks will be \$1,000 per semester for this year's recipients, for a total scholarship value of \$8,000 per recipient. This represents the stipend level that began with the class scholarship application cycle in 2011. It is recommended that the current total scholarship value be maintained for the new scholarship awards, beginning in Fall 2015, for a total scholarship value of \$8,000 per recipient. The amount of available funds for award is based upon the amount raised from all sources, less program expenses, between the previous two SOAR's (for the 2015 academic year's awards, that means from the end of SOAR 2013) through the end of SOAR 2014), with award recommendations being limited by that amount, plus additional funds as authorized by the SOA Board, if the Board deems it necessary or desirable. Some cushion has been maintained by students occasionally not remaining in the program, for one reason or another, by suspension for academic reasons, by not awarding full four year scholarships to advanced-standing students, and by not having an "even" amount for scholarships or by not having enough applicants for the amount raised in the previous year. This "cushion" enables us to occasionally have the flexibility to award additional scholarship money in any given year to deserving recipients. The program remains fiscally sound.

This year, in addition to the Special Operations Association Scholarship awards, an outside donor came forward once again and funded a separate one-year \$5,000 scholarship to one of our applicants in memory of his son, who was tragically killed in an accident while in his senior year of high school. The donor's son had intended to enlist in the US Army for Special Forces training as soon as he finished high school, so his father elected to sponsor a scholarship to a first generation child of a Special Operations Association member, with the award going through the American Veterans Center. We had one first generation applicant for a scholarship this year, and the donor he selected Mr. Sean L. Wilson to receive his scholarship. It will be presented to him at the annual AVC meeting in Washington, DC this November. The meeting will be carried live on the DoD News Channel (formerly the Pentagon Channel), and perhaps other commercial television channels. SOA will be represented at that presentation.

Through the Family Warriors Fund, Bill is able to bring family members of men killed in action during SOG's secret war, to SOAR.

Since the SOA membership approved the formation of the Family Warriors Fund, there have been several unique cases where family members were able to meet for the first time and talk with Green Berets and aviators who may have known their loved ones who remain listed as Missing In Action today and are presumed to be dead.

And, in unique cases, through the Family Warriors Fund, the committee is able to financially assist family members to attend SOAR thanks to the generous donations of SOA members.

Mary Queen, the widow of SOA member and DSC recipient Bill Queen, attended SOAR XXXVIII thanks to assistance through this fund. The brother and sister of Jerry "Maddog" Shriver attended SOAR XXXVII after receiving assistance from this fund.

Other relatives who attended SOAR XXXVIII included Judi Boyer Bouchard, sister of SOG MIA Alan Boyer, who went missing in action running a mission out of FOB 1 in March 1968. Over the recent decades, Judi has attended various hearings and POW/MIA gatherings, but learned very little about her brother Alan Boyer, of ST Asp.

"I'm so grateful to the SOA and to Bill for making it possible for me to attend the reunion this year," Judi said, "because I learned more about my brother in those few days and the type of missions he ran as a Green Beret, than I had any where else in recent decades."

With no other blood relatives alive, Judi said, "it was heartwarming to know that I am part of a bigger family.

"I want to thank Bill and the SOA for having me as their guest at this year's SOAR. It was truly an experience I will always remember. To be surrounded by so many heroes and meet guys who knew Alan was an amazing experience."

Another first-time SOAR attendee was Linda E. Haynie. In 1967, she met and fell deeply in love with Green Beret John T. Gallagher. At the time, she held a job in Atlanta while John went about training for a tour of duty in Vietnam at Ft. Bragg.

"We agreed to get married after he returned from Vietnam," Linda said, "but that wasn't meant to be."

On Jan. 5, running a mission from FOB 3 at Khe Sanh, John's helicopter was shot down. He was posted as MIA. For her, and John's family, the painful uncertainty of what happened to the Green Beret who had earned his Ranger tab before going to Nam in September 1967 began. John's remains were found March 15, 2002, identified November 2006 and he was buried next to his mother's grave in Hamden, CT on June 17, 2008.

The pain of not knowing what happened to John Gallagher haunted Linda, as she couldn't get any basic questions answered, even after his remains were identified and he was buried. Linda said she finally began to get a sense of what John did in SOG after reading two books: *Across The Fence* and *On The Ground*.

But, best of all for her was attending SOAR XXXVIII and to speak with six men who knew John and served with him in Vietnam.

"It was such an honor and a pleasure to meet the Band of Brothers of whom John was, and IS a part...Not only did they speak highly of him, 'Mr. Personality, everybody loved John,' but some hugged me and I instantly felt his presence in those embraces.

"Thank you for your kindness to me... He would be so proud to be a part of this amazing group of men and women who have kept the legacy of their astounding accomplishments alive...

"Needless to say, unless something catastrophic happens, I will be with Janet (McGovern) at the 2015 reunion next fall."

- 3. Two follow up claims for assistance were done after the reunion.


### Suggestions for improvement;

- **c. SOA RESPONSIBLE AGENT:** The Chairman, SOA Fund Raising Committee is the responsible "Agent", acting on behalf of the SOA Board of Officers and Directors in all matters relating to acceptance, or rejection of prospective Vendor/Exhibitor requests, or Placement of Advertisements in either SOA annual publications.
- **d. SOA BOARD:** Finally, in the event a prospective Vendor/Exhibitor or Advertiser does notagree with the decision of the Chairman, SOA Fund Raising Committee, the SOA Board is the final arbitrator. Anything that it deems is inappropriate will not be allowed for display or publication.

# **Endowments, Bequests, and Wills**

A number of SOA members have expressed an interest in including the association as a beneficiary on their wills, or other estate planning. The SOA has been requested to provide some information on what would be necessary to accomplish this task.

First - It is imperative that the membership understand that the SOA cannot provide any legal advice, or, can any information imparted to the membership be relied upon as "legal advice or legal language sufficient for all persons, jurisdictions and circumstances." Prospective benefactors must realize that laws on descent and devise, wills, trusts and estates vary from state to state. Typically, the laws of the state in which the benefactor was domiciled govern the administration of his estate, though even this can be affected by property in other states.

Second - Any member considering the SOA as a benefactor in his will must consult an attorney or licensed estate planner to ensure compliance with the laws of his state. For example, one aspect of trust and estate laws that does vary significantly is the number of witnesses necessary for a codicil or an amendment to a will (or for the creation of an entire will itself) to be validly created and recognized by the courts and law, and whether the document must have each of the witnesses' signatures notarized. Despite those variations in law, having at least two witness signatures notarized should ensure legal validity in most cases. Nevertheless, everyone is encouraged to consult an attorney to ensure that all laws and requirements have been met in all estate planning.

Third - The Special Operations Association will accept no responsibility or liability whatsoever for harm, difficulty, or invalidity of any will or other estate planning document which is adversely affected by a member (or his family's) sole reliance on this language without consulting a qualified attorney, licensed in the state in which the member is domiciled.

Fourth - The following is provided as possible language that could be included in a will where the testator wished to leave something to the Special Operations Association:

### I. General language for a Bequest

  - 1. The SOA George C. Morton Memorial Scholarship Program Fund."
  - 2. The SOA Operation Brightlight Program Fund."
  - 3. The SOA Save the Montagnard People (STMP) Program Fund."
  - 4. The SOA Personal Video History Project Fund."
  - 5. The SOA Warrior's Family Fund."

- C. "If at any time in the judgment of the governing body of the Organization, it is deemed impossible or impracticable to carry out the stated purpose of the bequest, the governing body of the Organization shall determine a purpose as near as possible to the purpose stated in the bequest."
- II. There are a multitude of other possibilities, some of which are:
  - A. Giving all or a percentage of what remains of an estate after all specific bequests having been satisfied and debts and expenses have been paid (the "rest, residue and remainder of the estate").
  - B. Give all or a portion of your estate in the event that a named beneficiary is not alive when the testator dies.
  - C. Establish a testamentary charitable trust in one's will, with a "pour-over" clause to designate which assets are to be placed in a trust with income paid to one or more beneficiaries for their lifetime, with the trust going to the veteran's organization upon

- A. the death of the last income beneficiary.
- B. Establish a trust in perpetuity in one's will, funded by some asset(s), (e.g., Life Insurance) with the beneficiary being the veteran's organization and the netincome to be paid to the veteran's organization and to be disbursed by the governing body of the veteran's organization either for a specific purpose or in their sole discretion.

Fifth - For your planning purposes, the Special Operations Association is recognized by the Department of Defense (DOD), and by the Internal Revenue Service (IRS) as a non-profit veterans organization 501 (c) (19), operating on tax deductible donations, (EIN # 74-2619854). Should you have any queries whatsoever, at anytime, always consult with your attorney.



Each print is 20 x 24 inches and contains the names of all of MACVSOG's Medal of Honor (MOH) recipients and the original signatures of the five surviving MACVSOG MOH recipients:

Col Robert C. Howard, US Army Special Forces, CCC, Hatchet Force Rescue (Most decorated serviceman in U.S. History, submitted for the MOH three times in 13 months and appearing on the cover of the Green Beret Magazine October 1969).

### NOTE: Colonel Howard passed away on 23 December 2009.

Col James P. Fleming, US Air Force 20th Special Operation Squadron's Green Hornet for rescuing RT Chisel, CCS, from imminent annihilation.

Lt Michael E. Thornton, US Navy SEAL, STDAT, for saving the life of Lt Thomas Norris an MOH recipient (The only time in US History when a recipient is awarded a MOH for saving the life of another MOH recipient).

Lt Thomas R. Norris, US Navy SEAL, STDAT, for the famed 4 day "Bat 21" rescues of two downed pilots. Six months later, he sustained a near-fatal head wound in action and was rescued by his fellow Navy SEAL, Michael Thornton.

SGM Jon R. Cavaiani, US Army Special Forces, CCN, for his two day defense of Radio Relay Site Hickory. He was captured dur-ing the battle and was a Prisoner of War (POW) in North Vietnam for 1 year and 8 months.

### Note: SGM Cavaiani passed away on 29 July 2014

### PRINT IMAGES

Upper Left: Lt George Sisler, FOB 2, Hatchet Force, was Killed in Action (KIA) in Feb 1967 during a bomb damage assessment (BDA). He was the first MACVSOG Medal of Honor recipient and the first intelligence officer ever to receive the MOH.

Lower Left: Major Larry A. Thorne was lost, Missing in Action (MIA), on MACVSOG's first mission, 18 October 1965. A native of Finland, he was a recipient of the Finnish Mannerheim Cross, the equivalent of the US Medal of Honor, while serving in the Finnish Army against Russia during WWII. His remains were recovered in Laos 37 years after being declared MIA.

Right Center: On strings, during a STABO extraction in 1968, are SFC Walter Hawley, SFC Agostino Chiarello, and SFC Clifford Roberts.


