Last year's reunion epitomized that sentiment when A-1 Skyraider pilots and ground crew members from Operating Location Alpha Alpha brought their photos and stories of supporting SOG to SOAR. I want to thank Don Engebretsen for being the point man on bringing OLAA men to SOAR XXXVII.



#### SECRET GREEN BERET COMMANDOS IN CAMBODIA

#### About the Book

We could call this book "special operations Recon Mission Impossible." A small group of highly trained, resourceful US Special Forces (SF) men is asked to go in teams behind the enemy lines to gather intelligence on the North Vietnamese Army units that had infiltrated through Laos and Cambodia down the Ho Chi Minh trails to their secret bases inside the Cambodian border west of South Vietnam. The covert reconnaissance teams, of only two or three SF men with four or five experienced indigenous mercenaries each, were tasked to go into enemy target areas by foot or helicopter insertion. They could be I5 kilometers beyond any other friendly forces, with no artillery support. In sterile uniforms - with no insignia or identification, if they were killed or captured, their government would deny their military connection. The enemy had placed a price on their heads and had spies in their Top Secret headquarters known as SOG.

SOG had three identical recon ground units along the border areas. This book tells the history of Command and Control Detachment South (CCS). The CCS volunteer warriors and its Air Partners- the Army and Air Force helicopter transport and gunship crews who lived and fought together and sometimes died together. This is the first published history of CCS as compiled by its last living commander some forty years after they were

disbanded. It tells of the struggles and intrigue involved in SOG's development as the modern-day legacy of our modern Special Operations Commands. Forbidden to tell of their experiences for over twenty years; their After Action Reports destroyed even before they were declassified surviving veterans team together to tell how Recon men wounded averaged 100 percent; and SOG became the most highly decorated unit in Vietnam and all were awarded the Presidential Unit Citation.

#### About the Author

Lieutenant Colonel Lindsey enlisted in the Army in 1948, attaining the rank of Corporal. He was accepted in to and graduated from the US Military Academy at West Point in 1954 as a 2nd LT of Infantry. After Infantry School, he qualified as a Master Parachutist and as a Ranger. He served in various leadership and staff positions in the 11th Abn Div, the 82nd Abn Div and the 101st Abn Div. In his first Vietnam combat tour he was MACV G-3 Air Liaison Officer for the 35th Tactical Fighter Wing and flew 50 backseat missions, primarily in F-100s. Then he went to 1st Brigade of 101st Abn Div as Asst Ops Officer and then Ops and Exec Officer of the 2/327Abn Inf Bn. On his second Vietnam tour, he was Cmdr of 2/8th Cav Bn of 1st Cav Div. Next he was Deputy Cmdr of OP-35 in MACV-SOG and then was Cmdr of Command and Control Detachment South (CCS) from January-July 1970. He is the last living Cmdr of CCS. His advance schooling included the USMA Preparatory School, a Masters degree at Indiana University, and the Command and General Staff College. He retired after 20 years from the Army in August 1972. His civilian career positions included Exec VP of an architectural and engineering firm; and president of an "Alternative Energy" firm building a Gasohol plant. He served for 12 years in the Indiana Department of Commerce as Program Manager for High Technology Development. His military awards include two Legion of Merit, two Bronze Stars, six Air Medals and the Combat Infantry Badge. Civilian awards are as a Kentucky Colonel and a Sagamore of the Wabash. He is active in local service and veterans' organizations in Carmel, IN, where he has lived with his family since 1973.





#### Announcing a New Book Project on Special Operations!

COL (Ret.) Joseph D. Celeski (Army, SF) is beginning a 18- to 24-month research project to publish in historical book form the roles and missions of selected special operations forces who supported the U.S. Ambassadors in Laos and the U.S. Embassy Project Evaluations Office (PEO) and later, the MAAG-Laos and Project 404, in Vientiane, Laos. This project is for non-profit, historical purposes only. These activities will include:

- 1st Phase: Operation HOTFOOT and WHITESTAR (and 1950s to 1962 advisory period)
- The 46th independent Special Forces Company in Thailand, who advised and served in Laos or trained Thais for service in Laos
- 2nd Phase: The Air Commandos & the attached Ravens (FACs)
- 3rd Phase: Project 404 SOF Advisors (AIRA and ARMA) who supported guerrilla op erations or facilitated other special operators (ground or air)

Although not intended to cover operations generated from South Vietnam, such as the MACV-SOG operations on the Ho Chi Minh Trail, or Air America and inter-agency operations, and USAF operations in the air war interdiction of the Ho Chi Minh trail, the book will necessarily include portions of those efforts as it relates to Secret War in Laos. The author intends to include in his research the following: Official reports, periodicals and books already in print; a visit to official archives of ARSOF and AFSOF, along with national-level service and history archives; interviews from a questionnaire and material generated from veterans of this conflict; input from the Veteran's associations relating to the topics above; and visits to archives held in relevant service museums. This publication will be generated all from open, unclassified sources.

REQUEST FOR ASSISTANCE: The author is looking for a variety of interviews (questionnaire will be provided) from Veterans who may have served in this capacity in Laos, as well as the opportunity to copy, with permission and source cited, a small amount of photos, leaflets, or other material for use in illustrating the book. These documents are preferred as scans somewhere in the 600 DPI range for suitability of reproduction in journal and book form. 

After all these years, he finally received recognition for his valorous actions on that horrible and endless early morning at CCN.

# THE PRESIDENTIAL UNIT CITATION (ARMY) FOR EXTRAORDINARY HEROISM TO THE STUDIES AND OBSERVATIONS GROUP.

#### UNITED STATES MILITARY ASSISTANCE COMMAND, VIETNAM

The Studies and Observations Group is cited for extraordinary heroism, great combat achievement and unwavering fidelity while executing unheralded top secret missions deep behind enemy lines across Southeast Asia. Incorporating volunteers from all branches of the Armed Forces, and especially, U.S. Army Special Forces, Special Operations Group's ground, air and sea units fought officially denied actions which contributed immeasurably to the American war effort in Vietnam. Military Assistance Command, Virtnam-Special Operations Group reconnaissance teams composed of Special Forces soldiers and indigenous personnel penetrated the enemy's most dangerous redoubts in the jungled Laotian wilderness and the sanctuaries of eastern Cambodia. Pursued by human trackers and even bloodhounds, these small teams out-maneuvered, out-fought and out-ran their numerically superior for to uncover key enemy facilities, rescue downed pilots, plant wiretaps, mines and electronic sensors, capture valuable enemy prisoners, ambush convoys, discover and assess targets for B-52 strikes, and inflict casualties all out of proportion to their own leases. When enemy counter-measures became dangerously effective, Special Operations Group operators innovated their own counters, from high altitude parachuting and unusual explosive devices, to tactics as old as the French and Indian War. Fighting alongside their Montagnard. Chinese Nung, Cambodian and Vietnamese allies, Special Forces-led Hatchet Force companies and plations staged during raids against key enemy facilities in Laos and Cambodia, overran major munitions and supply stockpiles, and blocked enemy highways to choke off the flow of supplies to South Vietnam. Special Operations Group's cross-border operations proved an effective economy-of-force, compelling the North Vietnamese Army to divert 50,000 soldiers to rear area security duties, far from the battlefields of South Vietnam. Supporting these hazardoos missions were Special Operations Group's own United States and South Vietnamese Air Force transport and helicopter squadrons, along with U.S. Air Force Forward Air Controllers and helicopter units of the U.S. Army and U.S. Marine Corps. These courageous aviators often flew through heavy fire to extract Special Operations Group operators from seemingly hopeless situations, saving lives by selflessly risking their own. Special Operations Group's Vietnamese naval surface forces - instructed and advised by U.S. Navy SEALS - boldly raided North Vietnam's coast and won surface victories against the North Vietnamese Navy, while indigenous agent teams penetrated the very heartland of North Vietnam. Despite casualties that sometimes became universal, Special Operations Group's operators never wavered, but fought throughout the war with the same flair, fidelity and intropidity that distinguished Special Operations Group from its beginning. The Studies and Observations Group's combat prowess, martial skills and unacknowledged sacrifices saved many American lives, and provide a paragon for America's future special operations forces.

# **Special Operations Association Reunion XXXVIII Annual General Member Meeting Standing Rules of Order**

#### **Preamble:**

The Board of Directors has created the following Standing Rules of Order in accordance with the directions and guidelines established in Chapter XIX of Roberts Rules of Order Newly Revised (RRNR).

The purpose of these Standing Rules of Order are to assure members' rights are fully protected, simplify what otherwise are sometimes confusing and contradictory Parliamentary Procedure options, establish order, and to capture the exact wording of proposed Topics of Discussion (TODs), Resolutions and Motions for the record.

These Standing Rules require approval by the General Members before they will be implemented and adhered to for this GMM. These Standing Rules of Order are Temporary and apply to this one single GMM only. Their authority ceases on the adjournment of the GMM.

We ask every General Member to read these proposed Standing Rules and to approve them with his vote.

Admission into the General Member Meeting room requires all members to wear or prominently display the Badge/Name tag issued by the Secretary/Registration Committee. General Members will be seated in the area designated by the Sergeants-at-Arms for "voting" members.

The Secretary, directly after the opening ceremonies, shall report the number of General Members registered at this year's SOAR and/or exclusively for the GMM and the number of those currently present in the meeting room. The number present at the beginning of the business meeting shall be the number used to determine if the SOA's quorum requirements have been met per Article VII Section C of the Bylaws. If the quorum requirement is met the number of members reported present shall be the base number for determining a majority for all votes conducted during this GMM.

All voting will be by physical count of hands or ballots. When voting, members are requested to raise their RIGHT hand over their heads in order that the Sergeants-at-Arms can facilitate a proper count.

General Members who desire to present a Topic of Discussion (TOD), Resolution or Motion from the floor that was not previously submitted to the Secretary per SOA Bylaws Article VII Section E must first submit a legibly written or typed copy to the Secretary prior to the opening the GMM but no later than the opening of New Business. If the request is in compliance with the Bylaws it will be added to the agenda under New Business in the order it was received by the Secretary.

At the appropriate time on the Agenda, the Secretary will request the Member who desires to open a TOD, make a Resolution or Motion to rise and request their TOD, Resolution or Motion to be read by the Secretary. In lieu of the President stating the question, the Secretary will

read the TOD, Resolution or Motion as presented and entered into the record at which time the Chair will call for a Second. If a Second is made, the Chair will then acknowledge the originating member who may then speak as defined in Rules 5 & 6, and, if appropriate, a vote will follow.

Two (2) microphones are available to members during debate. Any person wishing to speak during debate must do so from one of the microphones or he will not be recognized by the Chair. As designated, one microphone will be for those members who wish to speak in support of the question and the other for those opposed. When recognized, the member is requested to state his name and membership number prior to speaking.

Members are limited to two (2) three (3) minute periods of debate per question and a member will not be permitted to speak a second time until all other members who wish to speak to the question have spoken once. Total time for Debate will be limited to 12 minutes per question.

General Members may make a motion to set aside Rule 5 and substitute new requirements which will become the temporary Rule for that specific TOD, Resolution or Motion if passed by a 2/3rds majority (as is detailed in RRNR, page 253) of the quorum requirement as defined in Rule 2.

The Chair will rule out of order TOD(s), Resolution(s) or Motion(s) and not approve for discussion, debate and/or vote those subjects that violate the SOA Bylaws and those where the SOA Attorney and/or Attorneys for Association's Insurance Carrier have directed they not to be discussed beyond what has been previously posted by the BOD.

General Members may make a motion to set aside Rule 7 and if seconded and passed with a 2/3rds majority (ref. RRNR, page 253) of the quorum as defined in Rule 1. Prior to the vote, the Chair will provide the reason for his ruling, and if appropriate, either read or pass out copies of the board's posting(s). If the topic is one which the SOA's Lawyer and/or Insurance Company's Lawyer(s) has stated should not be discussed the Chair and the BOD will not answer questions or become involved in the debate. They will, however, participate in the vote if there is one.

General Members may appeal the President's rulings as stipulated in Section 24, pages 247-252 of RRNR. As stated on page 252, a majority or tie vote sustains the decision of the President. The President is authorized to vote in order to create a majority or tie decision.

The Chair will rule on all Parliamentary Questions in accordance with the authority granted in RRNR (pages 432 - 435 and elsewhere). At his discretion, as defined on page 243, the President may temporarily suspend the meeting, stand at ease, to obtain confidential advice from the Parliamentarian or other accepted parliamentary authority prior to making his ruling. Special attention is to be placed on "Decorum" specified on pages 379 - 384. A professional Registered Parliamentarian, (Mrs. Solveiga Unger) has been retained by the SOA Board to assist the President in the interpretation and application of parliamentary procedure.

All members and guests are required to turn off cell phones and pagers during the conduct of the General Member Meeting. Cell phones may be used to record the meeting if the ring and buzzer notifications are turned off. The use of recording devices is authorized.

# National League of Families of American Prisoners and Missing in Southeast Asia

As Chairman of the Special Operations Association (SOA) POW/MIA Committee, I had the honor of representing the SOA at the 45th Annual Meeting of the National League of Families of American Prisoners and Missing in Southeast Asia, 11-14 June 2014.

The League originated on the West Coast in the 1960s and was incorporated in 1970 in Washington, D.C. Voting membership is comprised of wives, children, parents, siblings and other close blood and legal representatives of Americans who are, or were, listed as Prisoners of War (POW), Missing in Action (MIA), Killed in Action/Body not Recovered (KIA/NBR) and returned American Vietnam (VN) War POWs. The League's sole mission is to obtain the release of all prisoners, the fullest possible accounting for the missing and the repatriation of all recoverable remains of those who died serving our nation during the VN War. Under the leadership of Chairman of the Board and Principal League Spokesperson, Ann Mills-Griffith (MIA sister and League Executive Director from 1978-2011), the league has become a powerful, effective and tireless nonprofit, tax-exempt, humanitarian organization that wields great influence in advancing their cause.

There are still 1642 personnel listed by the Department of Defense (DOD) as missing and unaccounted-for from the VN War (VN 1275, Laos 307, Cambodia 53, remainder over territorial waters). Joint POW/MIA Accounting Command (JPAC) Detachments in Bangkok, Hanoi, Laos and Cambodia are the tip of the spear in the recovery effort. Their personnel who presented briefings at the meeting were uniformly impressive. Most impressive of all was Maj Gen Kelly McKeague, USAF, Commander, JPAC. A compilation of their remarks presented the following picture of JPAC operations, successes and challenges:

- In VN, the government has lifted restrictions over the entire country and has become much more forthcoming with their military archives and Vietnamese veteran eyewitness accounts. But, the Vietnamese do not freely give everything they have; we must submit quarterly requests for information.
- In Laos, the government is fairly cooperative, but "nickels and dimes" us incessantly by charging exorbitant fees for vehicles, escorts, security, etc. far in excess of what should be necessary.
- Many JPAC operations must be postponed or cancelled, often at the last minute, due to budget and funding issues, sometimes due to Congressional inaction and other times due to adverse actions by US Pacific Command (USPACOM).

- A USPACOM hiring freeze has resulted in JPAC having too few forensic scientists for field teams they could otherwise deploy. This may be easing with recent "mission essential" hiring approval.
- Time is not on our side.
  - $\sqrt{\text{Veterans on both sides are dying or have fading memories.}}$
  - $\sqrt{}$  Sites are being degraded by urban, industrial and agricultural development.
  - $\sqrt{}$  Extreme acidity of the soil in Southeast Asia consumes remains rapidly, often leaving only teeth to recover and identify.
  - √ Fast-moving jets loaded with fuel and ordnance also often left only limited remains behind.
  - $\sqrt{}$  Access is limited by governments, weather and terrain. Late budgets can cause us to miss tight weather windows year after year.
  - $\sqrt{\ }$  The "easy cases" have been resolved. We're down to the difficult ones.

The Secretary of Defense has directed the acting Undersecretary of Defense for Policy to recommend a "plan for how to best organize DOD to most effectively increase to the maximum extent possible the numbers of missing Service personnel accounted for annually while ensuring timely and accurate information is provided to their families." This directive was largely driven by a year-old controversy started by a civilian employee of JPAC, a self-perceived "whistle-blower", who made many unproven, unwarranted allegations of wrong-doing and inefficiencies in DOD's current organizations and operations. The League welcomed Secretary Hagel's action, but also seemed supportive of JPAC in the face of the derogatory accusations, as evidenced by their presenting Commander, JPAC, with their highest honor, the League Award, at this year's meeting.

The individual heading the reorganization, Assistant Secretary of Defense for Special Operations and Low Intensity Conflict (ASD/SOLIC) is Michael Lumpkin, retired SEAL team commander. He faces a huge challenge: addressing structure, manning, budget, and operations in a single organization that encompasses the current activities of Defense POW/Missing Persons Office (DPMO), JPAC, Central Identification Laboratory, Defense Intelligence Agency Stony Beach, and support from agencies such as Life Science Equipment Laboratory, Armed Forces DNA Identification Laboratory, etc. At the meeting, Secretary Lumpkin stated he envisions combining these missions under a single Armed Forces Medical Examiner.

The most important impressions I took away from the meeting for SOA:

• My take on the reorganization: We do need one mission-oriented organization, but with checks and balances. Admittedly, there is room for streamlining the disparate organizations; but, the challenge will be to avoid throwing out the baby with the bath water. There are a lot of capable, dedicated professionals doing lots of good, hard work in this arena. They need to be preserved and protected.

- The government shutdown was a MAJOR setback. Five operations in VN and six in Laos had to be cancelled. JPAC had to cancel or defer 52% of planned first quarter missions. The US sent mixed signals and broke faith with the host nations they've worked so hard to cultivate. My opinion: Recovery and repatriation activities must be exempt from sequestration, as are Veterans Administration operations. POW/MIAs are unreturned veterans and deserve the same level of service as the VA's living veterans throughout and despite Congressional budget deliberations and political shenanigans.
- What can SOA do? Invite DPMO and JPAC participation at SOAR. Stay informed. Provide DPMO and JPAC researchers and operators with any eyewitness accounts or other information we can provide regarding our unrecovered brothers-in arms. Continue to support the efforts of the National League of Families and attend their annual meetings.
- What can SOA members do? Contact their Congressional representatives regarding our concern regarding lack of sustained, reliable funding for JPAC operations. These funds should be exempt from sequestration.

# **Operation Bright Light**

During the Vietnam War, there was a highly classified organization, code named, "Studies & Observation Group" (SOG). The unit was made up primarily of U.S. Army Special Forces (the Green Berets) but was augmented with other elite military organizations that were an integral part of Special Operations at the time. The skills and lessons learned by the SOG warriors made them the forerunner of today's Delta Force and the Navy SEALs.

As all operations in SOG were classified TOP SECRET, code names were assigned to the SOG personnel and their operations.

Teams were identified by code names; named after a snake, a state, or a tool and consisted of one (1) to four (4) American Green Berets. The number of additional personnel was dependent on the specific mission and was made up of indigenous personnel or mercenaries. Some teams were even made up of North Vietnamese Soldiers (NVA) that had been captured, retrained, and then paid to fight for the U.S. as mercenaries.

SOG warriors secretly penetrated deep into Laos and Cambodia to identify bombing targets, destroy troops, ambush trucks, mine roads, and, in the most difficult assignment, capture North Vietnamese soldiers for intelligence purposes. Always outnumbered and operating in the most dangerous and isolated conditions imaginable, SOG warriors matched wits with an unrelenting enemy that hunted them without mercy, in many cases using skilled trackers and dogs. As a result, they suffered an extraordinarily high casualty rate. Ten entire teams disappeared and another fourteen were overrun and annihilated.

Additional missions of the SOG warrior included the rescue of fighter and bomber pilots shot down behind enemy lines and the recovery of downed helicopter crews who supported the SOG missions. The most hated mission was recovery of team members that had been killed or wounded. The standard code name for those missions was "BRIGHT LIGHT".

Bright Light were words dreaded by all, as they knew someone was in serious trouble.

Today, as in the past, we have SOG warriors and members of the Special Operation Association who run into trouble. Some have fallen on hard times. Some are faced with unexpected expenses or their families are just a little bit short in making ends meet. All we need to know is that one of ours is in trouble and a "BRIGHT LIGHT" mission is announced over the network.

"OPERATION BRIGHT LIGHT" was founded by the Special Operations Association and its only mission is to help their own...warriors who are truly in need.

Today, we want to thank all the SOA Riders for their support in helping make this dream come true for Special Operations Warriors.

Each print is 20 x 24 inches and contains the names of all of MACVSOG's Medal of Honor (MOH) recipients and the original signatures of the five surviving MACVSOG MOH recipients:

Col Robert C. Howard, US Army Special Forces, CCC, Hatchet Force Rescue (Most decorated serviceman in U.S. History, submitted for the MOH three times in 13 months and appearing on the cover of the Green Beret Magazine October 1969). NOTE: Colonel Howard passed away on 23 December 2009.

Col James P. Fleming, US Air Force 20th Special Operation Squadron's Green Hornet for rescuing RT Chisel, CCS, from imminent annihilation.

Lt Michael E. Thornton, US Navy SEAL, STDAT, for saving the life of Lt Thomas Norris an MOH recipient (The only time in US History when a recipient is awarded a MOH for saving the life of another MOH recipient).

Lt Thomas R. Norris, US Navy SEAL, STDAT, for the famed 4 day "Bat 21" rescues of two downed pilots. Six months later, he sustained a near-fatal head wound in action and was rescued by his fellow Navy SEAL, Michael Thornton.

SGM Jon R. Cavaiani, US Army Special Forces, CCN, for his two day defense of Radio Relay Site Hickory. He was captured during the battle and was a Prisoner of War (POW) in North Vietnam for 1 year and 8 months.

#### PRINT IMAGES

Upper Left: Lt George Sisler, FOB 2, Hatchet Force, was Killed in Action (KIA) in Feb 1967 during a bomb damage assessment (BDA). He was the first MACVSOG Medal of Honor recipient and the first intelligence officer ever to receive the MOH.

Lower Left: Major Larry A. Thorne was lost, Missing in Action (MIA), on MACVSOG's first mission, 18 October 1965. A native of Finland, he was a recipient of the Finnish Mannerheim Cross, the equivalent of the US Medal of Honor, while serving in the Finnish Army against Russia during WWII. His remains were recovered in Laos 37 years after being declared MIA.
