

Archive and Video History Project volunteers, Terry Cadenbach and Kenyon Smith, met with Bob's sons and were presented with the warhead for display at the next SOAR. In the past Bob donated a number of items including the cutaway rocket that is always on display at the archive table. Please stop by during SOAR to see the new warhead addition. After being founded in 2009, the SOA Riders currently have 106 members on the rolls, but sadly, we too are seeing the effects of having older members. We seem to lose as many as we gain. If we are going to survive as an organization we need to reach out to those that followed us. As much as we hate to admit it, they aren't making anymore SOGers or Vietnam era air crews. It is our association, so we are the ones that have to sell it. Please join me in reaching out to the younger generation.

The riders have completed nine organized rides and ride number ten planning is well under way. Each ride has been an adventure in its own rite, with its own memories and stories. However, the reason we ride remains constant. We ride to honor our Brothers who remain missing. There are other good reasons, but they have been, are, and will remain our focus until they all come home.

Every year during the third week in May, just before Armed

Forces Day, we gather. We come from across the country to first spend a couple of days riding on day trips planned by the ride host. Days are spent being road warriors, riding the highways and byways, visiting points of interest, selected eating establishments, and the occasional watering hole. After a day in the saddle, evenings are spent sitting around telling tall tales that are always better than last year and get even better the later into the evening. Guests are always welcome and there are no strangers. On Saturday morning, Armed Forces Day, we ride to a predetermined location for a public ceremony to honor each of our missing Brothers from Studies and Observation Group and support units.

We ride for the sheer enjoyment of it. Rain or shine, heat or cold there is nothing better than the rumble of our iron steeds rolling down the highway and byways of America. 

MG John K. Singlaub Jedburgh Award

The second annual MG Singlaub Award was presented to Chief Warrant Officer 3 Lawrence K. Stindt, a Special Forces Soldier assigned to the 5th Special Forces Group (Airborne) on 21 January 2017 at the U.S. Army Special Operations Command's Red and Black Ball. The award was presented by LTG Ken Tovo (USASOC, Commanding General).

The Singlaub Award is an award created in honor and recognition of retired U.S. Army Maj. Gen. John K. Singlaub's courageous actions on and off the battlefield as well as his significant contributions to U.S. Army Special Operations Forces.

Part of CW3 Stindt's four-page citation reads: "From 2001 to 2015, CW3 Stindt served across the CENTCOM Area of Responsibility including the initial invasion of Afghanistan in support of Operation Enduring Freedom (OEF), as well as seven tours in support of Operation Iraqi Freedom (OIF), applying focused leadership at the tactical and operational levels in the fight for the future of both countries."





Two noteworthy combat accomplishments included the formation of the Iraqi 36th Commando Battalion and participation in 86 precision Special Operations raids that captured numerous high value targets and the valorous defense of the Golden Domed Mosque in Samarra, Iraq against Sunni extremists. CW3 Stindt excelled in combat as a Special Forces Non-Commissioned Officer and as a Warrant Officer.

CW3 Stindt received a rosewood plaque with a two-dimensional medallion bearing the raised likeness of Maj. Gen. Singlaub, donated by the Special Operations Association, and a USASOC certificate recognizing him as this year's Maj. Gen. Singlaub Award winner. In addition,

CW3 Stindt's name will be engraved on a command plaque displayed in the USASOC Headquarters building commemorating all future winners of the award.

Maj. Gen. Singlaub is a legend among SOF warriors, a forefather of the modern day Green Beret, and has had a long and distinguished career and history in Special Operations. He served in the office of strategic services (OSS) in WWII in both France and China. During the Korean War, he helped to create the Ranger Training Center at Fort Benning, GA and served with the CIA. During Viet Nam commanded an infantry battalion and commanded the Military Assistance Command Vietnam-Studies and Observation Group (MACVSOG)."

Standing Rules of Order

Special Operations Association Reunion XLI Annual General Member Meeting Standing Rules of Order

Preamble:

The Board of Directors has created the following Standing Rules of Order in accordance with the directions and guidelines established in Chapter XIX of Roberts Rules of Order Newly Revised (RRNR).

The purpose of these Standing Rules of Order are to assure members' rights are fully protected, simplify what otherwise are sometimes confusing and contradictory Parliamentary Procedure options, establish order, and to capture the exact wording of proposed Topics of Discussion (TODs), Resolutions and Motions for the record.

These Standing Rules require approval by the General Members before they will be implemented and adhered to for this GMM. These Standing Rules of Order are Temporary and apply to this one single GMM only. Their authority ceases on the adjournment of the GMM.

We ask every General Member to read these proposed Standing Rules and to approve them with his vote.

Admission into the General Member Meeting room requires all members to wear or prominently display the Badge/Name tag issued by the Secretary/Registration Committee. General Members will be seated in the area designated by the Sergeants-at-Arms for "voting" members.

The Secretary, directly after the opening ceremonies, shall report the number of General Members registered at this year's SOAR and/or exclusively for the GMM and the number of those currently present in the meeting room. The number present at the beginning of the business meeting shall be the number used to determine if the SOA's quorum requirements have been met per Article VII Section C of the Bylaws. If the quorum requirement is met the number of members reported present shall be the base number for determining a majority for all votes conducted during this GMM.

All voting will be by physical count of hands or ballots. When voting, members are requested to raise their RIGHT hand over their heads in order that the Sergeants-at-Arms can facilitate a proper count.

General Members who desire to present a Topic of Discussion (TOD), Resolution or Motion from the floor that was not previously submitted to the Secretary per SOA Bylaws Article VII Section E must first submit a legibly written or typed copy to the Secretary prior to the opening the GMM but no later than the opening of New Business. If the request is in compliance with the Bylaws it will be added to the agenda under New Business in the order it was received by the Secretary.

At the appropriate time on the Agenda, the Secretary will request the Member who desires to open a TOD, make a Resolution or Motion to rise and request their TOD, Resolution or Motion to be read by the Secretary. In lieu of the President stating the question, the Secretary will read the TOD, Resolution or Motion as presented and entered into the record at which time the Chair will

call for a Second. If a Second is made, the Chair will then acknowledge the originating member who may then speak as defined in Rules 5 & 6, and, if appropriate, a vote will follow.

Two (2) microphones are available to members during debate. Any person wishing to speak during debate must do so from one of the microphones or he will not be recognized by the Chair. As designated, one microphone will be for those members who wish to speak in support of the question and the other for those opposed. When recognized, the member is requested to state his name and membership number prior to speaking.

Members are limited to two (2) three (3) minute periods of debate per question and a member will not be permitted to speak a second time until all other members who wish to speak to the question have spoken once. Total time for Debate will be limited to 12 minutes per question.

General Members may make a motion to set aside Rule 5 and substitute new requirements which will become the temporary Rule for that specific TOD, Resolution or Motion if passed by a 2/3rds majority (as is detailed in RRNR, page 253) of the quorum requirement as defined in Rule 2.

The Chair will rule out of order TOD(s), Resolution(s) or Motion(s) and not approve for discussion, debate and/or vote those subjects that violate the SOA Bylaws and those where the SOA Attorney and/or Attorneys for Association's Insurance Carrier have directed they not to be discussed beyond what has been previously posted by the BOD.

General Members may make a motion to set aside Rule 7 and if seconded and passed with a 2/3rds majority (ref. RRNR, page 253) of the quorum as defined in Rule 1. Prior to the vote, the Chair will provide the reason for his ruling, and if appropriate, either read or pass out copies of the board's posting(s). If the topic is one which the SOA's Lawyer and/or Insurance Company's Lawyer(s) has stated should not be discussed the Chair and the BOD will not answer questions or become involved in the debate. They will, however, participate in the vote if there is one.

General Members may appeal the President's rulings as stipulated in Section 24, pages 247-252 of RRNR. As stated on page 252, a majority or tie vote sustains the decision of the President. The President is authorized to vote in order to create a majority or tie decision.

The Chair will rule on all Parliamentary Questions in accordance with the authority granted in RRNR (pages 432 - 435 and elsewhere). At his discretion, as defined on page 243, the President may temporarily suspend the meeting, stand at ease, to obtain confidential advice from the Parliamentarian or other accepted parliamentary authority prior to making his ruling. Special attention is to be placed on "Decorum" specified on pages 379 - 384. A professional Registered Parliamentarian, (Mrs. Solveiga Unger) has been retained by the SOA Board to assist the President in the interpretation and application of parliamentary procedure.

All members and guests are required to turn off cell phones and pagers during the conduct of the General Member Meeting. Cell phones may be used to record the meeting if the ring and buzzer notifications are turned off. The use of recording devices is authorized.



POW / MIA Committee Report 2017

POW/MIA Activity: Since SOAR 40 and Preparing for SOAR 41

GENERAL UPDATE

Sadly, little has occurred to address or lessen the concerns we highlighted at SOAR 40 and in the After Action Report: The position of Director, Defense POW/MIA Accounting Agency (DPAA), remains unfilled despite the availability of an eminently qualified candidate, Maj Gen (USAF, retired) Kelly McKeague. Adequate funding for DPAA operations in FY 2017 and beyond has not been secured. There is still a shortage of qualified DPAA Vietnam (VN) War analysts. Disinterred WWII and Korean War remains from US-controlled cemeteries continue to dominate identifications announced by DPAA.

As a result, the SOA and SFA leadership sent a letter to Secretary of Defense Mattis (reprinted here in the PRP) highlighting our concerns yet again and asking for his personal intervention. At a recent interment ceremony at Arlington Memorial Cemetery, Defense Secretary Mattis assured a senior DPAA official of his determination to get DPAA the best director he can. We trust he is a man of his word. Time will tell. Getting the right Director in place is the first step in addressing all of the concerns outlined above - and we need it sooner, rather than later.

CONGRESSIONAL SELECT COMMITTEE ON POW/MIA AFFAIRS?

US Representative Mark Walker (NC) recently introduced a resolution to establish a Select Committee on POW/MIA Affairs. SOA/SFA leadership, along with the leadership of the National League of POW/MIA Families, respects his well-meaning intent; however, we feel such a select committee would actually be counterproductive and a distraction from DOD's accomplishment of the accounting mission. We sent a joint SOA/SFA letter to Mr. Walker stating our position.

ONGOING SOUTHEAST ASIA (SEA) OPERATIONS

Due to funding constraints, DPAA dramatically reduced the scope of the VN Joint Field Activity (JFA) that began in March 2017. Initial plans were to conduct multiple recovery operations and investigations; but only one Investigation Team (IT) and one Recovery Team (RT), as well as a team to handle a Field Forensic Review and a Joint Forensic Review, were deployed. VN provided one Unilateral Recovery Team and one Research Investigation Team to supplement USG efforts.

A JFA in Laos was postponed due to an aircraft breakdown and delay in Guam, causing three RTs and one IT to lose several days. A trilateral investigation (US/Laos/VN) began as scheduled. Significantly, for the first time, DPAA teams were able to camp near recovery sites (increasing time on target) and to deploy teams in excess of the previous 53-person cap, both major initiatives DPAA successfully negotiated with Laos recently. The VN JFA was reduced, in part, to capitalize on this progress with the Lao.

In Cambodia, one site was excavated, but, cut from 60 to 30 days. This team was attempting to

account for two US servicemen from an aircraft crash site in northern Cambodia. SOA and SFA member James Shorten, who participated in a Brightlight mission at the crash site shortly after the incident, accompanied the DPAA teams to assist in their operations. We plan for James to brief us on his experiences at SOAR.

AMERICANS RECENTLY ACCOUNTED FOR IN SEA

In early 2017, USMC 1st Lt William C. Ryan, was the first person announced as accounted for from the VN War since June of 2016. On March 7th, DPAA announced that Captain Daniel W. Thomas, USAF, a Prairie Fire Forward Air Controller flying an OV-10 out of Nakhon Phanom, Thailand, listed as MIA on July 6, 1971, supporting a SOG team in South VN, had been accounted for. Remains were recovered by a Vietnamese Unilateral Excavation Team (UET) in August, 2014, and identified in August, 2015. Danny's FAC rider, Major Donald G. Carr, USA, CCN, had been identified in April 2016. Also, thus far in 2017, DPAA accounted for three USMC personnel lost in South VN in 1967: Capt John A. House, Cpl Glyn L. Runnels, Jr., and LCpl John D. Killen II; Col William E. Campbell, USAF, listed as MIA in Laos January 29, 1969; and Capt Robert R. Barnett, USAF, listed as KIA/BNR on April 7, 1966, while piloting a B-57B over Laos.

As of 1 April, the number still missing and unaccounted-for from the VN War was 1,611. Hopefully, by the time you read this, additional VN IDs may have reduced this number.

WE NEED YOUR HELP. WHAT CAN YOU DO?

Representative Sam Johnson (TX) and Senator John McCain (AZ) recently introduced identical resolutions in their respective Houses of Congress calling on the DOD, other elements of the Federal Government and foreign governments to intensify efforts to investigate, recover and identify missing and unaccounted-for personnel of the United States from previous wars and conflicts. Our Associations have endorsed passage of these resolutions; but, it would also be extremely helpful if each of you will write three letters, one to your representative and one to each of your two senators, endorsing passage, seeking co-sponsors, and encouraging them to vote for the resolution in their House. Sample letters are available on the SOA website "Members Only" page and can be edited to reflect your service. You can easily obtain the email address of your elected representatives on the Internet. (If not, get your kids and grandchildren to help you!) THIS IS IMPORTANT! Our attempts to motivate a letter-writing campaign have not been impressive in the past. Please help me combat apathy on this important issue.

Members with knowledge of cases involving missing comrades-in-arms, please interview with DPAA reps at SOAR. Bring maps, notes, other support materials, etc.

Subject: Defense POW/MIA Accounting Agency (DPAA) - Leadership, Funding and the "Numbers Game"

Dear Mr. Secretary,

On behalf of over 16,000 special operations veterans, the majority of whom are Vietnam War veterans, we express our grave concern with the obvious lack of attention being devoted to ensuring the Defense POW/MIA Accounting Agency (DPAA) has the necessary leadership and resources to effectively pursue the fullest possible accounting for our brothers-in-arms still missing and unaccounted for from our nation's past conflicts, especially the Vietnam War.

DPAA was created in 2015 to correct a dysfunctional situation caused by two disparate organizations being involved in command, control and execution of DOD's mission to account for US personnel missing from past conflicts. By direction of former SECDEF Chuck Hagel, the Defense Prisoner of War/Missing Personnel Office (DPMO) in Washington, DC, and the Joint POW/MIA Accounting Command (JPAC) in Hawaii were merged and placed under a single Director, along with the USAF Life Sciences Equipment Lab in Dayton, OH. The high hopes among POW/MIA family groups and veterans' service organizations generated by the formation of DPAA have largely dissipated for several reasons:

- DPAA reports to the Undersecretary of Defense for Policy (USDP), the selecting official for Director, DPAA. The first Director pledged to serve in that position for ten years; but, before the first anniversary of his appointment, he resigned. The Director's position has remained vacant since June 2016. USDP's failure to name a new Director in a timely manner is symbolic of the paucity of attention USDP has been devoting to actual recovery of missing and unaccounted for personnel. It certainly hinders DPAA's ability to effectively execute its mission. The first Deputy Director, Maj Gen (USAF, retired) Kelly McKeague, served as the last Commander, JPAC, with great distinction. He corrected many systemic problems he inherited and earned the respect and support of POW/MIA families and veterans service organizations. When he applied for the vacant Director's position, his application was endorsed by many of these groups. Another candidate was selected, but withdrew at the last minute. In our opinion, Kelly McKeague should have been selected and on duty long ago.
- DPAA budget requirements were not met in FY16 and long-planned missions were cancelled or reduced. It now appears DPAA will *not* have the funding in FY17 required to "increase the pace and scope of operations," as has repeatedly been requested by Vietnam and planned by DPAA. Despite the lack of a permanent director, DPAA had been proceeding well since becoming fully operational in January of 2016. Now, the lack of a permanent director and

funding issues are impacting the mission. It is our understanding that a known \$20 million plus-up needed to reach the necessary FY17 budget of \$132 million for planned operational requirements was not requested. Further, even had the funding been requested and approved, these funds would be available too late for use in the 3rd and 4th quarters of FY17.

- The lack of a new director and the failure to take advantage of opportunities to increase the
 pace and scope of operations can only raise doubts among host nation partners to America's
 commitment to the mission. The USG is sending absolutely the wrong message to
 counterparts in foreign governments. We ask partners to increase cooperation, then fail to
 fund our own planned activities.
- Congress has directed DPAA to develop the *capability and capacity* to accomplish 200 identifications of remains per year. Some in DPAA purposefully or inadvertently misinterpret the intent of Congress to mean that they must identify 200 annually, starting now. A strategy has been adopted to disinter commingled remains of the known dead, buried as unknowns in US-controlled cemeteries, then use new DNA techniques to identify personnel who are not truly missing. It is much cheaper, faster and easier to rack up ID numbers this way, than to fund field operations to locate and recover the truly missing. More difficult and expensive Vietnam War investigation and recovery operations are at a disadvantage in the competition for resources if identifications become a "numbers game".

It is our urgent request that you direct the current acting Under Secretary of Defense for Policy to move as quickly as possible to fill the DPAA director position with a qualified leader and take measures to ensure that DPAA receives the necessary funding in order to pursue its worldwide mission, especially the fullest possible accounting for our personnel lost in the Vietnam War. This will require that better leaders be put in charge of USDP who understand and support the accounting mission. DPAA's career civil servants are mainly dedicated professionals in dire need of the leadership, policy support and funding they deserve. Their mission fulfills a sacred obligation from this country to the personnel it sends into harm's way. We urge you to commit the necessary time, energy, and resources of the Department of Defense to fulfill that obligation.

Endowments, Bequests and Wills

A number of SOA members have expressed an interest in including the association as a beneficiary on their wills, or other estate planning. The SOA has been requested to provide some information on what would be necessary to accomplish this task.

First - It is imperative that the membership understand that the SOA cannot provide any legal advice, or, can any information imparted to the membership be relied upon as "legal advice or legal language sufficient for all persons, jurisdictions and circumstances." Prospective benefactors must realize that laws on descent and devise, wills, trusts and estates vary from state to state. Typically, the laws of the state in which the benefactor was domiciled govern the administration of his estate, though even this can be affected by property in other states.

Second - Any member considering the SOA as a benefactor in his will must consult an attorney or licensed estate planner to ensure compliance with the laws of his state. For example, one aspect of trust and estate laws that does vary significantly is the number of witnesses necessary for a codicil or an amendment to a will (or for the creation of an entire will itself) to be validly created and recognized by the courts and law, and whether the document must have each of the witnesses' signatures notarized. Despite those variations in law, having at least two witness signatures notarized should ensure legal validity in most cases. Nevertheless, everyone is encouraged to consult an attorney to ensure that all laws and requirements have been met in all estate planning.

Third - The Special Operations Association will accept no responsibility or liability whatsoever for harm, difficulty, or invalidity of any will or other estate planning document which is adversely affected by a member (or his family's) sole reliance on this language without consulting a qualified attorney, licensed in the state in which the member is domiciled.

Fourth - The following is provided as possible language that could be included in a will where the testator wished to leave something to the Special Operations Association:

- I. General language for a Bequest
 - A. "I give all my real and personal property to the Special Operations Association, a veteran's fraternal organization, in care of Brian Vines, Secretary, SOA, located at 847 Coleman Drive The Villages, FL 32163, for its unrestricted use." Or,
 - B. "I give all my real and personal property to the Special Operations Association, a veteran's fraternal organization, in care of Brian Vines, Secretary, SOA, located at 847 Coleman Drive The Villages, FL 32163, for the specific purpose of supporting (one of the following specific projects):
 - 1. The SOA George C. Morton Memorial Scholarship Program Fund.
 - 2. The SOA Brightlight Program Fund.
 - 3. The SOA Personal Video History Project Fund.
 - 4. The SOA Warrior's Family Fund.
 - 5. The SOA General Fund.

- II. Specific Bequest language:
 - A. "I give ______ (\$\$\$ amount, description of item, e.g., car, boat, etc., legal description of real property home, farm, etc., or a % of residue or remainder of estate, a specific asset/stock/security) to the Special Operations Association, a veteran's fraternal organization, in care of Brian Vines, Secretary, SOA, located at 847 Coleman Drive The Villages, FL 32163, for its unrestricted use." Or,
 - B. "I give ______ (\$\$\$ amount, description of item, e.g., car, boat, etc., legal description of real property home, farm, etc., or a % of residue or remainder of estate, a specific asset/stock/security) to the Special Operations Association, a veteran's fraternal organization, in care of Brian Vines, Secretary, SOA, located at 847 Coleman Drive The Villages, FL 32163, for the specific purpose (one of the following specific projects):
 - 1. The SOA George C. Morton Memorial Scholarship Program Fund.
 - 2. The SOA Brightlight Program Fund.

 - 5. The SOA General Fund.
 - C. If at any time in the judgment of the governing body of the Organization, it is deemed impossible or impracticable to carry out the stated purpose of the bequest, the governing body of the Organization shall determine a purpose as near as possible to the purpose stated in the bequest.
- III. There are a multitude of other possibilities, some of which are:
 - A. Giving all or a percentage of what remains of an estate after all specific bequests having been satisfied and debts and expenses have been paid (the "rest, residue and remainder of the estate").
 - B. Give all or a portion of your estate in the event that a named beneficiary is not alive when the testator dies.
 - C. Establish a testamentary charitable trust in one's will, with a "pour-over" clause to designate which assets are to be placed in a trust with income paid to one or more beneficiaries for their lifetime, with the trust going to the veteran's organization upon the death of the last income beneficiary. Establish a trust in perpetuity in one's will, funded by some asset(s), (e.g., Life Insurance) with the beneficiary being the veteran's organization and the net income to be paid to the veteran's organization and to be disbursed by the governing body of the veteran's organization either for a specific purpose or in their sole discretion.

Note - For your planning purposes, the Special Operations Association is recognized by the Department of Defense (DOD), and by the Internal Revenue Service (IRS) as a non-profit veterans organization 501 (c) (19), operating on tax deductible donations, (EIN # 74-2619854). 

SECRET GREEN BERET COMMANDOS IN CAMBODIA

A Memorial History of MACV-SOG Command and Control Detachment South (CCS), And Its Air Partners, Republic of Vietnam, 1967-1972

About the Book

We could call this book "special operations Recon Mission Impossible." A small group of highly trained, resourceful US Special Forces (SF) men is asked to go in teams behind the enemy lines to gather intelligence on the North Vietnamese Army units that had infiltrated through Laos and Cambodia down the Ho Chi Minh trails to their secret bases inside the Cambodian border west of South Vietnam. The covert reconnaissance teams, of only two or three SF men with four or five experienced indigenous mercenaries each, were tasked to go into enemy target areas by foot or helicopter insertion. They could be 15 kilometers beyond any other friendly forces, with no artillery support. In sterile uniforms - with no insignia or identification, if they were killed or captured, their government would deny their military connection. The enemy had placed a price on their heads and had spies in their Top Secret headquarters known as SOG.

SOG had three identical recon ground units along the border areas. This book tells the history of Command and Control Detachment South (CCS). The CCS volunteer warriors and its Air Partners- the Army and Air Force helicopter transport and gunship crews who lived and fought together and sometimes died together. This is the first published history of CCS as compiled by its last living commander some forty years after they were

disbanded. It tells of the struggles and intrigue involved in SOG's development as the modern- day legacy of our modern Special Operations Commands. Forbidden to tell of their experiences for over twenty years; their After Action Reports destroyed even before they were declassified surviving veterans team together to tell how Recon men wounded averaged 100 percent; and SOG became the most highly decorated unit in Vietnam and all were awarded the Presidential Unit Citation.

About the Author

Lieutenant Colonel Lindsey enlisted in the Army in 1948, attaining the rank of Corporal. He was accepted in to and graduated from the US Military Academy at West Point in 1954 as a 2nd LT of Infantry. After Infantry School, he qualified as a Master Parachutist and as a Ranger. He served in various leadership and staff positions in the 11th Abn Div, the 82nd Abn Div and the 101st Abn Div. In his first Vietnam combat tour he was MACV G-3 Air Liaison Officer for the 35th Tactical Fighter Wing and flew 50 backseat missions, primarily in F-l00s. Then he went to 1st Brigade of 101st Abn Div as Asst Ops Officer and then Ops and Exec Officer of the 2/327Abn Inf Bn. On his second Vietnam tour, he was Cmdr of 2/8th Cav Bn of 1st Cav Div. Next he was Deputy Cmdr of OP-35 in MACV-SOG and then was Cmdr of Command and Control Detachment South (CCS) from January-July 1970. He is the last living Cmdr of CCS. His advance schooling included the USMA Preparatory School, a Masters degree at Indiana University, and the Command and General Staff College. He retired after 20 years from the Army in August 1972. His civilian career positions included Exec VP of an architectural and engineering firm; and president of an "Alternative Energy" firm building a Gasohol plant. He served for 12 years in the Indiana Department of Commerce as Program Manager for High Technology Development. His military awards include two Legion of Merit, two Bronze Stars, six Air Medals and the Combat Infantry Badge. Civilian awards are as a Kentucky Colonel and a Sagamore of the Wabash. He is active in local service and veterans' organizations in Carmel, IN, where he has lived with his family since 1973.

During the Vietnam War there was a special breed of warrior, whose assignments were among the most dangerous. Their efforts served all the fighting men in Vietnam. They performed strategic reconnaissance. It meant high-risk duty running recon deep in enemy territory, collecting intelligence, extracting downed pilots, raiding suspected POW camps, spiking enemy supply caches and striking at the enemy from within.

We know them as U.S. Army Special Forces, SEALs, Air Commandos, Force Recon, and SAS. Beyond these honored titles, and a handful of others, participants in Special Operations defy easy description. Today America Remembers is proud to honor all of these heroic warriors who served in Southeast Asia with the Special Operations Association Vietnam Tribute Pistol – a handsome Tribute issued on a legendary military sidearm, the Browning Hi-Power pistol.

From launch sites inside Vietnam, such as Kham Duc, Phu Bai, and others, members of the Studies and Observations Group (SOG) served covertly behind enemy lines, often in very dangerous situations and in difficult terrain. The young American warriors left behind the comforts of home for an uncertain fate on a far-off treacherous battlefield, putting their lives on the line in support of freedom and liberty, and serving with valor and distinction.

A Trusted Military Sidearm – A Fitting Tribute

In Vietnam, the Browning 9mm Hi-Power was a favorite combat sidearm for SOG warriors who operated secretly behind enemy lines. It featured a large magazine capacity, and was rugged, reliable and effective. In fact, the Browning Hi-Power was so respected, this classic military firearm was used for special presentations to recognize outstanding accomplishments. Designated the "Reconnaissance Team Leader Special Recognition Award," and called the "Silver Pistol," this unique presentation was awarded to a very limited number of individuals during the Vietnam War.

The Special Operations Association Vietnam Tribute from America Remembers features dramatic and powerful artwork honoring those who served in Southeast Asia.

The Tribute is authorized by the Special Operations Association, a fraternal organization of American and foreign participants of special military operations in a combat theater, primarily in Southeast Asia. For this Tribute, each working pistol is decorated with 24-karat gold and nickel artwork by craftsmen specifically commissioned by America Remembers, and it is available nowhere else.

Conrad "Ben" B. Baker was inducted as the 12th Honorary Member of the Special Forces Regiment on April 27, in Northern California. Amongst the many achievements Baker accomplished as the deputy director for the Counterinsurgency Support Office that served SOG and other agencies during the Vietnam War was the research and development of specially designed rations for the indigenous troops who support Special Forces and other agencies during the Vietnam War. Under Project PIR, Baker is seen holding a box of Indigenous Rations used by Montagnard, Nung, Vietnamese and other indigenous personnel during the war. Baker estimated that 66 to 86 million Indigenous Rations were purchased and provided to troops supporting the U.S. war effort.



The Special Forces Regiment approved the induction of Mr. Conrad Ben Baker as an Honorary Member of the Regiment (HMOR), the highest Regimental honor bestowed on a civilian. Mr. Baker's induction plaque, along with a picture, will be placed in the Special Forces Hall of Fame at the US Army John F. Kennedy Special Warfare Center and School permanently.

Ben received an honorary Green Beret by BG Healy in 1971 for his work in Vietnam. Ben worked as a DA Civilian for the Counterinsurgency Support Office (CISO), and was liaison between the SOG and ODA's throughout the Republic of Vietnam where he traveled extensively during the Vietnam War.
